#### CONSIDERING TAFE OR UNI?

Now that you have finished your formal schooling, the world is your oyster. If you choose to engage in further education or training, the options are limitless and can be a little bit confusing at times. TAFE and Universities, whilst both are learning institutions function differently to each other and it is important to pick which learning and content delivery style will suit you best.

The biggest difference between TAFE and University is that TAFE is more of a hands on approach than University which is made up of lecturers and tutorials. For example, a design course at a University will have more theory attached to its coursework whilst the same course at a TAFE level will have you doing more practical work to obtain your competencies.

#### HOW DO I APPLY FOR UNIVERSITY OR TAFE?

When you finish your schooling and want to start applying for courses, whether it be university, TAFE or a private institution, you will need to go through the <u>Victorian Tertiary Admissions Centre (VTAC)</u>. VTAC is the central office which processes and administers all the application and offers for the whole of Victoria.

#### RESUME

Your resume (sometimes known as your "CV") is an important tool when applying for a job as it is the first impression you will make. It doesn't matter how qualified you are, or how much experience you have - if your resume is poorly presented, badly written or has spelling/grammatical errors you're going to have trouble getting the job you want - or even an interview.

#### YOUR EMPLOYMENT RIGHTS / FAIR WORK

Employees in Victoria (and Australia) have certain rights in the workplace. These include the right to:

- Basic rates of pay and casual loading
- Hours of work
- Annual leave
- Personal/carer's & compassionate leave
- Unpaid parental leave

When you commence employment, your employer is expected to provide you with a copy of the Fair Work Information Statement. The Fair Work Information Statement outlines minimum workplace entitlements and is part of the National Employment Standards (NES).



#### STARTING YOUR OWN BUSINESS

Starting a new business is a big job, but don't let that put you off. Thousands of people do it every day and those collective experiences have given us guidelines. Although, starting a business isn't one big decision; it's hundreds of small decisions. If you want to succeed, you need to move through them systematically and with a cool head. #### BASIC CHECKLIST



#### **UNIQUE SELLING POINT (USP):**

Work out what your business will consist of; for example your product/service



#### **REGISTER BUSINESS NAME/ABN:**

Go to <u>asic.gov.au</u> to first check your name availability before creating a logo



#### **BUSINESS INSURANCE:**

Even the smallest companies need insurance. Talk to a broker to find out more.



#### **BUSINESS PLAN:**

Summarise your business as it is now, & map your vision for how it will be in the future



#### **BUSINESS BANK ACCOUNT:**

Don't use your personal account; it's wise to keep your business finances separate



#### WEBSITE / SOCIALS:

Set up a website & various social network accounts that are right for your business

#### SELF-EMPLOYMENT ASSISTANT

<u>Self-Employment Assistance</u> can help you turn your business idea or existing small business into a viable business. The program allows you to choose the level of support that meets your needs and the needs of your small business.

To be eligible **you must be at least 15 years of age** (a person must be 18 years of age to access Small Business Coaching).

#### XERO ACCOUNTING SOFTWARE

<u>Xero's small business accounting software</u> has all the time-saving tools you need to grow your business. From importing bank transactions to sending invoice reminders, Xero automatically handles tasks so you can get your accounting done faster.

<u>Xero</u> also offers a free online e-book called <u>"How to Start a Business"</u> which will walk you through the process.

#### TAX FILE NUMBER (TFN)

A **tax file number (TFN)** is your personal reference number in the tax and superannuation systems. It's **free** to apply for a tax file number and it will become part of your identity so be sure to *keep it secure*. It's also yours for life, even if you change your name, change jobs, move interstate or go overseas. For more information or to apply for a TFN, if you haven't already go to **ato.gov.au** 

#### BANKING

You will need to consider setting up a bank account, if you haven't already. The bank should be able to help you take control of your money & help you to save. To set up a bank account you will need a tax file number, proof of address, identification and money (these days you only need \$1 to open an account). You can set up an account online or speak to a branch manager and they will be able to assist you. If you are unsure of anything be sure to ask!

#### **BUDGETS**

A budget basically keeps track of:

- Money you regularly earn (from wages, salary) - this is called your income
- Money you regularly spend (rent, food, bills, mobile phone, etc.) - this is called your expenses

Once you subtract your expenses from your income, your left with your "disposable income" - money you can afford to spend on things you like or put into a savings account.

#### FINANCIAL SUPPORT

#### CENTRELINK

Various types of financial support is available for people aged 16 - 24 years who are studying full-time, undertaking a full-time Australian Apprenticeship, training, looking for work or who are sick.

You can find out what your eligible for by answering some simple questions.

#### **CONCESSION CARDS**

Some payments entitle you to a <u>Health Care Card</u>. You are eligible for this if you are a low income earner or are receiving Newstart Allowance, Parenting Payments, Sickness Allowance, Mobility Allowance, Carer Allowance or Special Benefit.

If you receive Youth Allowance, Abstudy or Austudy you will not automatically receive a Health Care Card but may still qualify for a Low Income Health Care Card.

Contact <u>Centrelink</u> to confirm you eligibility or go to <u>servicesaustralia.gov.au</u> to find out more.

#### **MEDICARE**

Medicare provides access to medical and hospital services for all Australian residents and certain categories of visitors to Australia. Once you turn 15 years old you can apply for a Medicare card. When getting your own Medicare card you can either get a card that is linked to your parents and remain on theirs, or get an entirely separate one.

You will be required to have a Medicare card to visit a doctor and will then be charged a portion of the cost of the visit, or it may be FREE.

#### SUPERANNUATION

Your superannuation is your future. It's money set aside during your working life for when you retire. For most people, super begins when you start work and your employer starts paying a portion of your salary or wages into a super fund for you. If you're a contractor or a temporary resident and are working in Australia, you may also be entitled to super. If you're self-employed, you can choose whether to contribute super for yourself.

#### RENTING

If you're considering or have made the decision to move out of home, there are several things to consider. You will need to have some money saved up to cover the bond and one months rent in advance as well as household items such as furniture, appliances and bedding. Purchasing and arranging things before you move out can make the transition much smoother.

**HousingVic** (housing.vic.gov.au) makes it easier to find the right information about housing and housing assistance in Victoria. Try the **Housing Options**Finder: answer a few questions to see what housing options may be right for you as well as check your eligibility for various help & services.

To find a rental property or search for rooms in share houses go to realestate.com.au or search realestate.com.au & download the mobile app. Also be sure to check University/TAFE noticeboards, the local paper & also search gumtree.com.au or download the Gumtree mobile app.

#### **BOND ASSISTANCE**

A rental bond is a security deposit a tenant pays before moving into a property. It is held by the **Residential Tenancies Bond Authority (RTBA)** and is paid back to the tenant at the end of the tenancy provided no money is owed to the property manager/owner for rent, damages or other costs.

#### **DRIVING L2P**

The **TAC L2P Program** assists disadvantaged Victorian learner drivers aged 16 to 21 with no access to a supervising driver or vehicle to gain the 120 hours driving experience required to apply for a probationary licence. For more information on L2P go to vicroads.vic.gov.au or swanhill.vic.gov.au

In addition, when buying a second hand car a good resource to check prior history on the vehicle including money owing and if it has ever been reported stolen or written off is the Personal Property Security Register (PPSR) and costs less than \$5.
